Should I/We fail to pay the amount due and demanded as provided herein, within a period of one month from receipt of the notice of demand, BMPC shall have the right to exercise its rights as are available under the law. In case of judicial execution of the obligation or any part of it, I/We shall pay to the former the costs of collection and attorneys' fee in an amount equivalent to Twenty Percent (20%) of the unpaid principal, interests and penalties due thereof, which shall in no case be less than Five Thousand Pesos (P5,000.00).
