It is further agreed by parties hereto that in case payment shall not be made at maturity, the borrower shall pay the cost of collection and attorney's fees in an amount equal to twenty percent (20%) of the principal and interest due in this note, but such charge in no event shall not be less than FIVE THOUSAND PESOS (P5, 000.00).

In case of judicial execution of this obligation or any part of it, the debtor waives all his/her rights under the provisions of Rule 3, Section 13 and Rule 39, Section 12 of the Rules of Court.
